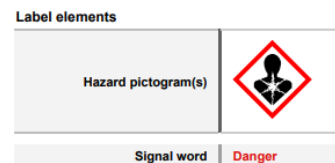

6.1. Personal precautions, protective equipment and emergency procedures

Skin contact: The liquid may be able to be mixed with fats or oils and may degrease the skin, producing a skin reaction described as non-allergic contact dermatitis.
